

MGM Executive Bill Boasberg Named President & COO of Beau Rivage

LAS VEGAS, Sept. 21, 2017 -- MGM Resorts International [NYSE: MGM] today announced the appointment of Bill Boasberg as president and chief operating officer of Beau Rivage Resort & Casino in Biloxi, Miss., where he will oversee daily operations while providing strategic direction.

Mr. Boasberg began his career in hospitality and gaming in New Orleans, his hometown. Most recently, he has served as the top executive at MGM National Harbor, where he led the Maryland team through the resort's successful opening in December.

Mr. Boasberg will assume his new role at Beau Rivage later this year, after completing licensing requirements. He succeeds Marcus Glover, who in July was named president and COO of Borgata Hotel Casino & Spa in Atlantic City.
